The Fellowship Forum

An Idea and Its Expression

The Fellowship Forum had its beginning in November 1950, during a meeting of two friends, Graeff Kennedy and Paul Stinchfield, who chatted together, leisurely, at lunch. Both men were members of the Commonwealth Club of California and agreed that their future attendance at meetings of that Club would be uncertain and difficult because of their permanent residence in the Palo Alto area. They spoke of missing the fellowship, stimulus, and wealth of information, which attendance at those meetings brought them, and wished there might be a group in Palo Alto, organized to meet similar needs of those with like interests, —those who were unable to avail themselves regularly of the privileges of the Commonwealth Club.

These men continued their luncheons, inviting friends of similar interests to join them, with the idea of developing a group who would be interested in the promotion of fellowship and in the discussion of world affairs.

The idea of an organization was developed, and at a meeting on December 27, 1950, a name, "The Fellowship Forum," was adopted. Paul Stinchfield was chosen as Chairman and Harry R. Leland as Secretary-Treasurer. Arrangements were made for regular weekly luncheon meetings at Hotel Marie Antoinette, Menlo Park. During the first few months the membership grew to include the following men: George Blech, Joseph G. Brown, W. Waldo Freeman, John S. Hassan, Arthur G. Kennedy, Leslie I. Nichols, Charles T. Owens, George J. Peirce, Charles L. Plato, Jesse B. Sears, Charles A. Simonds, Fritz Barkan, and Guy LeRoy Stevick.

With this increase in membership the need for a more formal organization was recognized. An election of officers, President, Vice-President, and Secretary-Treasurer, to serve for one year, was therefore held on April 24, 1951. John S. Hassan of San Mateo was elected the first President of the Forum under the new set-up. Business, Executive, and Membership Committees were established and appointed by the President. A similar election was held in April 1952, at which time Dr. J. B. Sears was elected President for the fiscal year.

The Rules of the Forum provide that partisan political and denominational religion shall not be discussed by our speakers. A maximum limit of thirty-five was placed upon the Club's membership.

The Fellowship Forum, it is believed, has become a permanent part of the cultural and intellectual life of the community. Many distinguished men have addressed the Club's meetings; their talks have been outstanding. The Forum has provided an unique, intellectual, and social stimulus for its members and friends.
