## Fellowship Forum The Development of An Idea

The beginning of the idea of the Fellowship Forum emerged in November, 1950 during a luncheon conversation of Graeff Kennedy and Paul Stinchfield. These men continued lunching together, inviting friends of similar interests to join them, with the idea of developing a group interested in the promotion of fellowship and in the discussion of world affairs and other matters of common interest. On December 27, 1950 an informal organization was formed, named "The Fellowship Forum." Paul Stinchfield was chosen Chairman and Harry R. Leland Secretary-Treasurer. Arrangements were made for weekly luncheon meetings at Hotel Marie Antoinette, Menlo Park.

As the membership of the group increased the need for a more formal organization was recognized and on April 24, 1951 John S. Hassan was elected President under the new set-up. In April 1952 Jesse B. Sears was chosen the second

President of the organization.

Under the leadership of President Sears a systematic statement of "Rules and Regulations" was developed. This formulation, adopted May 5, 1953, provides for three classes of membership: Active membership, limited to thirty-five men, which implies regular attendance and participation in the activities of the Forum; Associate membership which may be granted to an active member who finds he cannot attend meetings regularly; Honorary membership which may be conferred on worthy persons by recommen-dation of the Governing Board and approval of the Forum.

The officers of The Fellowship Forum are President, Vice-President, Secretary, and Treasurer. These officers with the retiring president form the Governing Board which is charged with the responsibility for formulating policies and plans and for passing on nominations for membership and proposals for additions to or amendments of the Forum's Rules and Regulations." Decisions of the Governing Board are presented as recommendations to the Forum. On December 22, 1953 the "Rules and Regulations" were amended changing the date of the annual election of officers from May to December. It was also voted that the officers elected in May, 1953 would continue until the first regular meeting

in January, 1955.

The Fellowship Forum is a group of men animated by a desire for fellowship and an opportunity to increase their understanding of world affairs and other matters of common interest. Weekly meetings are planned by the Program Committee. Usually the group is addressed by a guest speaker. Following the address members have an opportunity to ask questions or to comment on points made by the speaker. Occasionally a meeting is devoted to the discussion of an announced topic. The rules of the Forum provide that partisan political issues and denominational religion shall not be discussed by a speaker. The luncheon meetings of the Fellowship Forum are on Tuesday at the Hotel Marie Antoinette, Menlo Park. Members may entertain guests at the luncheons.
