The Fellowship Forum

The beginning of the idea of the Fellowship Forum emerged in November, 1950 during a luncheon conversation of Graeff Kennedy and Paul Stinchfield. These men continued lunching together, inviting friends of similar interests to join them, with the idea of developing a group interested in the promotion of fellowship and in the discussion of world affairs and other matters of common interest. On December 27, 1950 an informal organization was formed, named "The Fellowship Forum". As the membership of the group increased, the need for a more formal organization was recognized and the present Bylaws have been developed as a statement of rules for conducting the activities of the Forum.

Active membership, which implies regular attendance and participation in the activities of the Forum, is limited to forty men. The Bylaws provide for honorary membership which may be conferred on worthy persons by recommendation of the Governing Board and approval of the Forum.

The officers of the Forum are, President, Vice-President, Secretary, and Treasurer. These officers with the retiring president and the chairman of the Program Committee form the Governing Board which is charged with the responsibility for formulating policies and plans and for passing on nominations for memberships and proposals for additions to or amendments of the Forum's Bylaws. Decisions of the Governing Board are presented as recommendations to the Forum.

The Forum is a group of men animated by a desire for fellowship and an opportunity to increase their understanding of world affairs and other matters of common interest. The luncheon meetings of the Forum are held on Tuesday of each week at the Hotel Marie Antoinette in Menlo Park. Members may entertain guests at the luncheons. Following the luncheon there is a program, arranged by the Program Committee, when the group is addressed either by a Forum member, or more frequently, by a guest speaker. Following the address members have an opportunity to ask questions or to comment on points made by the speaker. The rules of the Forum provide that partisan political issues and denominational religion shall not be discussed by the speaker. Occasionally a meeting is devoted to a group discussion of an announced topic.

The Record of Programs for 1954 lists 12 addresses by Forum members and 34 by guest speakers. The titles of these addresses reflect the broad range of the interests of the group.

With all of its accomplishments and satisfactions, 1954 brought to us profound sorrow in the passing of not fewer than five of our highly respected members. To them, we pay this expression of our lasting affectionate regard — to their families our deep sympathy and condolences.
