### The Fellowship Forum

The Fellowship Forum is a group of men having a desire for fellowship and an opportunity to increase their understanding of world affairs and other subjects of common interest. The idea for such an organization was conceived by two friends, Paul Stinchfield and Graeff Kennedy, who were in the habit of lunching together and who wished there might be such a group in Palo Alto. On December 27, 1950, they invited several of their friends to a luncheon at Marie Antoinette Inn, Menlo Park, and presented their idea to them. The plan was enthusiastically approved and the name "The Fellowship Forum" was adopted upon the suggestion of Mr. Stinchfield, who was chosen as provisional chairman.

In the beginning the form of organization was very simple. Weekly luncheons were held at which each member in turn was given the responsibility of presenting a subject for discussion by the group. During the first few months the membership increased, guest speakers were added and a set of Bylaws was drawn up and adopted. The Bylaws provide for officers to be elected annually. The officers, together with the junior Past President and the Chairman of the Program Committee constitute the Governing Board. The Board is responsible for formulating policies; for passing on nominations for membership referred to it by the Membership Committee; and for making recommendations on all proposals for amendments to the Bylaws. All decisions of the Governing Board are submitted to the Forum for approval.

Luncheon meetings of the Forum are held each Tuesday at Marie Antoinette Inn. Members may entertain guests at the luncheon. Following the luncheon there is a program, arranged by the Program Committee, when the group is addressed by a guest speaker or by a member of the Forum. Following the address members have an opportunity to comment or ask questions on points made by the speaker. The rules of the Forum provide that partisan political issues and denominational religion shall not be discussed by the speaker. Occasionally a meeting is devoted to a group discussion of an announced topic. The Record of Programs for 1957 indicates the broad range of subjects presented by members and guests.

Active membership, which implies regular attendance and participation in the activities of the Forum, is limited to forty-five men. Allowing for leaves of absence, the attendance of active members has averaged approximately 80%. This indicates the interest which the members of the Forum have in the programs and the high degree of fellowship which prevails.
